Commissioner Erb called the meeting to order.

#### **MOMENT OF SILENT REFLECTION:**

Commissioner Erb called for a moment of silent reflection.

#### PLEDGE OF ALLEGIANCE TO THE FLAG:

Commissioner Erb requested that all present stand and recite the Pledge of Allegiance to the Flag.

#### APPROVAL OF MINUTES - MAY 22, 2018:

Commissioner Erb called for corrections or changes to the meeting minutes of May 22, 2018. **There were no corrections or changes noted.** 

Motion by Commissioner Beam, seconded by Commissioner Tomassetti and unanimously approved to accept the minutes as prepared.

#### **PUBLIC COMMENT:**

Commissioner Erb called for public comment.

Mr. Joe Koehle, an Altoona resident, stated his concerns regarding the proposed Senate Bill 1006. He stated that he thought building permits were to make certain that repairs and improvements completed to a property were completed according to required codes however, he feels they are being used as an enforcement measure for the county. Mr. Koehle feels that basic maintenance and repairs to maintain the existing property value should not be considered a taxable item. However, for a project such as building a garage or other structure he has no problem paying taxes.

Mr. John Kasun, an Allegheny Township resident, stated that he and other concerned citizens understand that Senate Bill 1006 is not the issue and understand that the unclear, existing law only came to light because the proposed Senate Bill 1006 was introduced keeping intact the unclear language. He stated that he would like to see the unclear sections of the law repealed or addressed to be clearer.

Rep. John McGinnis, 79<sup>th</sup> District, stated that he is trying to enact an amendment to clean up the language in the existing law and asked for the commissioner's help to get the County Commissioners Association of Pennsylvania (CCAP) to support the proposed amendment. He stated that there is a possibility that the \$2,500.00, increase in value figure will be raised to \$4,000.00. He is proposing an escalation clause be added as well.

Rep. McGinnis stated that proposed Senate Bill 1006 is about uniformity and fairness. The bill will help to address situations where municipalities aren't submitting building permits to the Assessment Offices in a timely manner.

Ms. Rhonda Holland, a Tyrone Borough resident, and President of the Blair County Tea Party, stated that the Tea Party just held a meeting on proposed Senate Bill 1006. One of the questions she has been asked since the meeting is if something is considered an improvement and is taxable are property owner's going to get depreciation on that improvement?

Mr. Christopher Creek, Antis Township resident, stated his primary concern is on who interprets and decides what is considered a substantial improvement? He stated that the term substantial improvement is not defined. Who determines what constitutes an increase in value of more than \$2,500.00? Who makes the determination of what steps are necessary to follow if no building permit is required?

Commissioner Tomassetti read the following Proclamation:

## PROCLAMATION CELEBRATING THE BICENTENNIAL OF THE UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF

### THE UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF PENNSYLVANIA

**WHEREAS**, the Judiciary Act of 1789, adopted on September 24, 1789 in the first session of the First United States Congress, established the federal judiciary of the United States; and

WHEREAS, the Western District of Pennsylvania was established by the Act of April 20, 1818, which divided the commonwealth of Pennsylvania into two judicial districts, with the Western District consisting of the counties of Fayette, Greene, Washington, Allegheny, Westmoreland, Somerset, Bedford, Huntingdon, Centre, Mifflin, Clearfield, McKean, Potter, Jefferson, Cambria, Indiana, Armstrong, Butler, Beaver, Mercer, Crawford, Venango, Erie and Warren; and

**WHEREAS**, the United States District court for the Western District of Pennsylvania, in 1866, after having previously held sessions only in Pittsburgh, began holding sessions in Erie, Pennsylvania; and

**WHEREAS,** IN 1978, Congress approved the creation of the United States Bankruptcy Court, as a unit of the District Court, including the establishment of the United States Bankruptcy Court for the Western District of Pennsylvania, and

**WHEREAS**, the Court, in 1989 and acting upon a longstanding Congressional authorization, announced that it would hold sessions in Johnstown, Pennsylvania; and

WHEREAS, fifty-seven men and women have served the Court as a United States District Judge, fourteen have served as a United States Magistrate Judge and twelve have served as a United States Bankruptcy Judge; and

WHEREAS, the United States District Court for the Western District of Pennsylvania currently exercises jurisdiction over 25 counties with three divisional offices in Erie, Johnstown and Pittsburgh, Pennsylvania, has ten authorized District Judgeships and is served by four District Judges, five Senior District Judges, six Magistrate Judges and four Bankruptcy Judges; and

**WHEREAS**, the mission of the United States District Court for the Western District of Pennsylvania is to preserve and enhance the rule of law while providing an impartial and accessible forum for the just, timely and economical resolution of legal proceedings within the Court's jurisdiction, so as to protect individual rights and liberties, promote public trust and confidence in the judicial system, and to maintain judicial independence; and

WHEREAS, the judges of the District Court are called on to hear and decide cases covering a wide range of issues. Such disputes include cases involving the civil and criminal laws of the United States, cases that deal with the constitutionality of those laws, civils rights cases, cases that involve disputes which occur on our waterways, and cases that involve disputes between parties who reside in different states; and

**WHEREAS**, the United States District Court for the Western District of Pennsylvania is recognized throughout the nation for its standards of excellence, fairness, and professionalism; and

**WHEREAS**, in 2018, We, the Blair County Board of Commissioners, join in celebrating the 200<sup>th</sup> Anniversary of the United States District Court for the Western District of Pennsylvania, and offer our sincere gratitude to those thousands who have served, and who currently serve, as public servants, striving to uphold the Constitution, balancing the scales of justice for all.

Commissioner Tomassetti presented discussion concerning SB 1006. Amending the Consolidated County Assessment Law to further provide for building permits.

Commissioner Tomassetti introduced DeAnna Heichel Blair County's Chief Assessor. Commissioner Tomassetti asked Ms. Heichel numerous questions pertaining to Senate Bill 1006.

Ms. Heichel stated that proposed Senate Bill 1006 would aid the county in obtaining building permits from the municipalities within the county in a timely fashion. The building permit is the primary way the assessment office finds out about property improvements that could substantiate a new assessment of the property. She stated that improvements such as new cabinets, carpeting, roof repair or replacement probably wouldn't generate an increase in the property's assessed value.

Ms. Heichel stated that it is not fair to the citizens of the county when improvements to a property are not reported and the value of their property remains the same, but the same improvements to a separate property are reported and the assessed value goes up.

Discussion followed.

Commissioner Tomassetti encouraged Commissioner Erb and Commissioner Beam to support the proposed Senate Bill 1006 while enforcing the need for changes to the existing law's language.

Both Commissioner Erb and Beam stated that they would not support the proposed bill until the current vagueness and lack of definitions to the current law are addressed by lawmakers.

Discussion followed.

Motion by Commissioner Erb, seconded by Commissioner Beam and unanimously approved to adopt Resolution 205-2018.

#### **Social Services:**

Trina Illig requested acceptance of two (2) Grant Awards from the Pennsylvania Housing Finance Agency (PHFA) for Pennsylvania Housing Affordability and Rehabilitation Enhancement Fund for \$40,000 for the Rental Assistance Program and \$150,000 for the Water and Sewer Program.

Discussion followed.

Commissioner Erb stated he was notified at a recent County Commissioners Association of Pennsylvania (CCAP) meeting that the Pennsylvania Commission on Crime and Delinquency (PCCD) is submitting a proposal for funding under Category 3 for the Department of Justice, Justice and Mental Health Collaboration Program. At that time, he was asked if the county would consider submitting a Letter of Support the PCCD application. Commissioner Erb stated that the county would be interested in being considered for these program funds, should PCCD be successful in their grant application. Commissioner Erb stated that the funds would assist with increasing public safety and reducing recidivism among individuals with mental health and substance abuse.

County Administrator Schmitt stated that the approval is for a Letter of Support for the grant application being submitted by PCCD, and if awarded, additional discussions and recommendations for the use of the funds could be discussed at that time.
