


Highlights for February 2025

- While 2023 preliminary drug overdose death estimates as of February 2025 have not exceeded 2022 estimates (4,720 vs. 5,164; currently an 8.6% decrease), 2023 estimates are still high and indicate that there continues to be a critical need for sustained and improved overdose prevention and surveillance efforts.
- Rates among Black, Indigenous, People of Color (BIPOC) continue to remain higher than rates among white and non-Hispanic individuals and show smaller decreases in rates than decreases seen in white and non-Hispanic individuals.
 - 2023 preliminary estimates show a decrease among all demographic groups except individuals aged 65+, which show a 20% increase in 2023 compared to 2022.
- While there was a steady decrease in the number of drug overdose deaths from February – April 2024, we are seeing minor increases in May and June 2024 (see slides 5 and 6).
- There are no changes in the number of county Coroner and Medical Examiner Offices participating in enhanced overdose death surveillance efforts.



Estimated Drug Overdose Deaths, 2017 – 2024‡





Pennsylvania Estimated Any Drug[†] Overdose Deaths By Month, 2020-2024[‡]



Pennsylvania Estimated Any Drug[†] Overdose Deaths By Month, 2017-2024[‡]



Estimated Any Drug[†] Overdose Deaths by Demographics, 2017 – 2023[‡]





Pennsylvania Unintentional Any Drug[†] Overdose Deaths, Counts by County, 2023[‡] (n=4,720)




