Public Comment:

Commissioner Erb called for public comment. There were no comments noted.

Special Presentation on CCAP 2022 Priorities Toolkit:

Broadband Expansions – Commissioner Erb

It would not be an exaggeration to say that the future quality of life in Blair County hinges on addressing the challenges to broadband expansion that are preventing access to opportunities and information to many of our citizens.

You may recall that our regional comprehensive plan for the Southern Alleghenies region, which was titled Alleghenies Ahead, and Blair County's comprehensive plan identified broadband investment and expansion as a top priority.

While these plans were adopted pre-pandemic, the COVID crisis highlighted the existing gaps and the need for new and better broadband connections for businesses, schools, and homes.

With the promise of millions of dollars in federal investment in the commonwealth and the development of the statewide Pennsylvania Broadband Development Authority, many of the key pieces are coming together to facilitate the implementation of strategic, thoughtful approaches to move Blair County and all of Pennsylvania forward.

Adequate and affordable broadband connection is critical to everyday functions of life, and, with a once-ina lifetime investment of funding for broadband development, county government stands ready to continue aiding in bridging the digital divide through stakeholder partnerships.

Business, education, health care, emergency services, and other key parts of our everyday lives truly rely on access to broadband, even more so now as the pandemic has changed the way and the reasons our people use the internet.

Collaboration will be critical.

The commonwealth must develop partnerships among federal, state, and local government as well as the private sector to identify successful approaches and best practices that can remedy the problem.

These may include:

- Working together with federal, state, local, and private stakeholders for successful broadband expansion that maximizes resources and minimizes overbuild.
- Partnering with higher education and research entities to leverage data, develop needed informational resources, and build on technological innovations that aid in advancement of broadband infrastructure deployment and service provision.
- Identifying funding resources and partnering with stakeholders to ensure deployment of resources are responsibly allocated to best fit the areas of greatest need.

A key component to securing federal funding for Pennsylvania's broadband infrastructure was the creation of the Statewide Broadband Development Authority established under Act 96 of 2021.

The Authority is responsible for strategic planning and funding for broadband development to unserved and underserved areas, including access to the millions of dollars in federal funding allocated to the commonwealth in the Infrastructure Investment and Jobs Act.

Blair County is very fortunate in having our own Brandon Carson recently being named as Executive Director for the Statewide Broadband Authority.

Brandon served for many years as the Planning Director for the Southern Alleghenies Planning & Development Commission and more recently was overseeing Alleghenies Broadband, Inc. or ABI.

The formation of ABI was a key outcome from the Alleghenies Ahead regional comprehensive plan I referenced earlier.

ABI is serving Blair County as well as the Commission's five other member counties as the functional intermediary facilitating the various state and federal funding sources for broadband development in the region.

Our long-term goal is a fiber-optic network reaching as much of the county's population and geography as possible.

We are in the midst of the first step in that process with ABI contracting with the Foresight Group to complete a regional fiber-optic network design that will provide the framework for constructing a reliable, high-speed fiber network.

We will have a comprehensive, long-term strategy that addresses lack of internet connectivity in the region, enables the securing of available federal and state resources to construct the infrastructure, and ensures the most efficient use of those available funding resources by reducing duplication of efforts from the public and private sectors.

Working together with the all of the various public and private partners, we will build a brighter future for Blair County for generations to come.

(FDR, Inc.) for the SWAN Legal Services Initiative (SWAN LSI) Paralegal(s) for the period of 07/01/21 through 06/30/22.

<u>Resolution 207-2022</u>: A resolution approving a Lease Agreement by and between the County of Blair, and the Altoona-Logan Township Mobile Medical Emergency Department Authority (AMED) for location of communication equipment (listed in Exhibit A) upon the county's communication tower identified as Number P-1802, located at 916 Fire Tower Road, Altoona, PA in the monthly rental amount of \$1.00, commencing on 07/01/22 and continuing for a period of two-2 years.
