Commissioner Burke noted her abstention on the payment of invoices to Blair Senior Services due to a conflict of interest.

Motion by Commissioner Webster, seconded by Commissioner Erb and unanimously approved to adopt Resolution 378-2022 with the abstention as noted.

Staff Reports & Special Business:

Southern Alleghenies Service Management Group:

Kelly Popich requested approval for the submission of an Early Intervention (EI) Toddler Work Force Development Grant Application to the Office of Child Development and Early Learning (OCDEL), in the total amount of \$31,974.00, to support the retention/and or recruitment of Service Coordinators, for the period of September 2022 through January 2023; and authorization for Jim Hudack, MH/ID/EI Administrator, to sign said grant application.

Ms. Popich stated that there is no county match of funds associated with the grant.

Discussion followed.

Social Services:

a. Melissa Gillin requested approval of a FY 2022/2023 renewal contract between the County of Blair and Central PA Behavioral Health Collaborative (CPBHC), d/b/a Blair HealthChoices, in the maximum contract amount of \$400,000.00, for the period of July 1, 2022 through June 30, 2023.

Ms. Gillin stated the department's boilerplate, business associate agreement and the insurance documents have been reviewed by Solicitor Karn. She stated the contract is funded with the Human Services Block Grant for Mental Health.

Discussion followed.

b. Ms. Gillin requested approval of a FY 2022/2023 renewal contract between the County of Blair and UMPC Altoona, in the maximum contract amount of \$1,250,000.00, for the period of July 1, 2022 through June 30, 2023.

Ms. Gillin stated the department's boilerplate, business associate agreement and the insurance documents have been reviewed by Solicitor Karn. She stated the contract is funded with the Human Services Block Grant for Mental Health.

Discussion followed.

c. Melissa Gillin requested approval of a Purchase of Service Agreement between the County of Blair on behalf of the Department of Social Services and the Law Office of Stephen D. Wicks, to provide Mental Health Procedures Act (MHPA) legal representation, both consultative and court appearances, at the hourly rate of \$160.00, for the period of July 1, 2022 through June 30, 2023.

Ms. Gillin stated that Solicitor Karn has reviewed the agreement. She stated there has been no change in the agreement from the previous year.

Discussion followed.

Fort Roberdeau:

Glenn Nelson requested approval of a Security Services Agreement between the County of Blair and Keystone Investigation and Security Specialists, LLC to provide three-3 security guards at the Fort Roberdeau Halloween Adventure, from 5:30 pm to 9:30 pm, Saturday, October 8, 2022 at the rate of \$23.00 per hour/per guard for a total of \$276.00, to be paid by the Fort Roberdeau Association.

Mr. Nelson stated that the agency has provided security services for the Halloween event since 2017. He stated that Solicitor Karn has reviewed the agreement and insurance documents.

Discussion followed.

Finance:

Lindsay Dempsie requested approval for the acceptance of bids received for cleaning services for various county office buildings (Magisterial District Judges', 911/E Center, Adult Parole Satellite Office, Fort Roberdeau and Coroner's Office).

Ms. Dempsie stated that there were no bids received for the advertised cleaning services. She stated that the services have been re-advertised in accordance with the County Code.

Discussion followed.

Commissioner's Office:

a. Chief Clerk Hemminger requested approval to advertise for the adoption of an ordinance pertaining to Local Economic Revitalization Tax Assistance (LERTA) and improvement of deteriorating real property or areas of tax exemption act (RLERTA). Said eligible location is the entirety of the Townships of Catharine and Woodbury and the Borough of Williamsburg, Blair County, Pennsylvania.

Chief Clerk Hemminger stated that a joint public hearing regarding the RLERTA was held on August 29, 2022 at the Williamsburg Community Farm Show Building. The LERTA meeting was held on July 18, 2022. She stated the eligible location would be the entirety of Catharine and Woodbury Townships and Williamsburg Borough. The ordinance would allow an exemption of county real property taxes. Year one at the rate of 100%, year two at 80%, year three at 60%, year four at 40% and year five at 20% with the exemption of taxes terminating after year five.

Discussion followed.

b. Chief Clerk Hemminger requested approval for the adoption of a Resolution of the Board of Commissioners of the County of Blair, Pennsylvania complying with the requirements of Act 57 of 2022 (HB 430) which amends the Local Tax Collection Law to allow taxpayers who fail to receive a tax notice during their first year of occupancy to receive a waiver of penalties and additional costs from the tax collector, after being shown proof of the property transfer, and directing other necessary and proper action.

Solicitor Karn stated that the County of Blair as well as all tax bodies need to comply with the requirements of Act 57 of 2022, House Bill 430, by adopting a Resolution that allows a taxpayer who fails to receive a real estate tax notice within the first year of acquiring a property to seek a waiver of additional costs and fees from failure to pay the real estate taxes on time. He stated that Act 57 becomes effective as of October 10, 2022, and requires adoption of a resolution by all taxing bodies by January 7, 2023.

Discussion followed.

c. Chief Clerk Hemminger requested approval to amend Resolution 151-2010, dated April 13, 2010, *THE COUNTY OF BLAIR CONSULTANT SELECTION PROCEDURE*, for the selection of a County Engineer for professional engineering services needed for transportation and other projects.

Chief Clerk Hemminger stated that PennDOT requires the selection process for all PennDOT funded projects and the engineer named will be the engineer on all future PennDOT funded projects.

Discussion followed.

<u>Resolution 379-2022</u>: Approving to amend Resolution 151-2010, dated April 13, 2010, *THE COUNTY OF BLAIR CONSULTANT SELECTION PROCEDURE*, for the selection of a County Engineer for professional engineering services needed for transportation and other projects.

Motion by Commissioner Webster, seconded by Commissioner Burke and unanimously approved to adopt Resolution 379-2022.

d. Chief Clerk Hemminger requested approval to advertise for Statements of Interest for the County of Blair Engineer of Record Selection Process.
