Approval of Meeting Minutes: 07/26/22 and 07/28/22

Commissioner Erb called for corrections or changes to the meeting minutes of 07/26/22 and 07/28/22.

Motion by Commissioner Webster, seconded by Commissioner Burke and unanimously approved to accept the minutes as prepared.

Public Comment:

Commissioner Erb called for public comment.

There were no comments noted.

Unfinished Business:

Adoption of Resolutions:

Resolution 280-2022: Approving a Pennsylvania Commission on Crime and Delinquency (PCCD) Probation with Restrictive Conditions Subgrant Award #2022-IP-ST-37214, in the total amount of \$315,000.00, for the period of 07/01/22 through 06/30/22.

Motion by Commissioner Burke, seconded by Commissioner Webster and unanimously approved to adopt Resolution 280-2022.

Resolution 281-2022: Approving an Amendment to the Comprehensive Health Services Agreement by and between the County of Blair, and PrimeCare Medical, Inc., dated 03/01/18, amending said agreement to provide an additional full-time Licensed Clinical Social Worker (LCSW) for forty (40) hours per week, Monday-Friday, with compensation increased by \$91,034.88 per year/\$7,586.24 per month, in addition to the amounts set forth in the underlying agreement. The month in which services commence, compensation shall be prorated.

Resolution 282-2022: Approving an Addendum to the Statement of Work (SOW) dated 01/06/22, between the County of Blair, Blair County Children, Youth and Families (CYF) and CAI Health & Human Services, to identify viable candidates for open staff positions, for pricing at 20% of the annual salary outlined in the county's offer letter upon hire with 50% payable immediately and 50% payable upon the candidate's successful completion of ninety (90) days of employment.

Commissioner Webster requested approval of one-1 Penn State University intern, Evangeline (Angie) Miller, for the period of August 29, 2022 through December 2, 2022 (120 hours). Internship is for credit only and at no cost to the county.

Commissioner Webster stated all the required documents pertaining to the internship have been received and approved by the Human Resources Department. She stated that the internship is at no cost to the county.

Chief Clerk Hemminger stated that Resolution 249-2022 dated 07/07/22 authorized Mike Polosky of Efficient Energy Solutions to lock in the rate for 50% of the county's natural gas at a rate up to 4.39 fixed for a period of twenty-four (24) months.

Chief Clerk Hemminger stated Mr. Polosky was unable to secure that rate, therefore, Resolution 249-2022 will need to be amended to reflect a different rate and terms. She stated that Mr. Polosky has not yet provided the rates for today.

Commissioner Erb recommended that the Board consider authorizing Mr. Polosky to lock in the rate for 50% of the county's natural gas at a rate up to 5.30 fixed for a period of twenty-four (24) months.
