Blair County Agricultural Land Preservation/Conservation District:

a. Donna Fisher requested approval for the reappointment of Palmer Brown to the Blair County Agricultural Land Preservation Board to serve a three (3) year term for the period of 01/01/18 through 12/31/20.

Miss Fisher stated that Mr. Brown has served on the Blair County Agricultural Land Preservation Board for a number of years and brings a wealth of knowledge to the board. She stated that Mr. Brown is willing to serve another three (3) year term.

Discussion followed.

Resolution 7-2018: A resolution approving the reappointment of Palmer Brown to the Blair County Agricultural Land Preservation Board to serve a three (3) year term for the period of 01/01/18 through 12/31/20.

Motion by Commissioner Tomassetti, seconded by Commissioner Beam and unanimously approved to adopt Resolution 7-2018.

b. Donna Fisher requested approval for the reappointment of John Black as the Blair County Agricultural Land Preservation Chairman for 2018.

Miss Fisher stated that according to the Blair County Agricultural Land Preservation Board by-laws the Board of Commissioners are to appoint a Chairman of the Board annually. She stated that Mr. Black has served as Chairman the past several years and is willing to continue in that role.

Discussion followed.

Resolution 8-2018: A resolution approving the reappointment of John Black as the Blair County Agricultural Land Preservation Chairman for 2018.

c. Donna Fisher presented discussion concerning an allocation and the source of the allocation of county funds for the purchasing of agricultural conservation easements for 2018.

Miss Fisher stated that the farmland preservation program began in 1991 with the first easement sold in 1993. Since that time, the county has averaged approximately two (2) easements per year. To date, the county has fifty (50) easements for total of just over 7,500 acres.

Miss Fisher stated that annually the Board of Commissioners allocates funds to the program and those funds are then matched by state funds. She stated that since the inception of the program Blair County has contributed \$1,190,710.00. In recent years, the County has been able to allocate Act 13 Marcellus Shale Funds.

Discussion followed.

Resolution 9-2018: A resolution approving an allocation of 2018 County Match Funds, in the amount of \$80,000.00, paid from Act 13 Marcellus Shale Funds, to the Blair County Agricultural Land Preservation Program, for the purchasing of agricultural conservation easements pursuant to the authority contained in the Act of June 30, 1981 (P.L. 128, No. 43), known as the Agricultural Area Security Law, as amended.
