Homeless Shelter

• Lisa Hann, Family Services Executive Director, reported the bids for the homeless shelter were awarded to 4 contractors (general, HVAC, plumbing and electrical) on August 2, 2021. Contractors will have to present their plans on what they are going to do. Preconstruction meeting, with contractors, is being planned for next week. Contractors have 270 days to complete the construction. Contract was signed for PHARE funding for \$200,000. Tax credits should be coming along soon. Dave Macharola is the Clerk of Works.

Other Programs:

Lead Abatement Program (Trina Illig)

Blight/Demolition Fund

Missy stated that there has not been any requests presented since the last Affordable Housing Trust Fund. Missy, Jim and Commissioner Erb clarified some of the details on past expenditures. Jim added that a report is submitted to the state every year detailing the approved demolition projects.

TEAMeffort

Landlord/Tenant Mediation Program (Lisa Hann)

• Lisa Hann commented that there has been no further applications for mediation, even with the eviction moratorium being lifted. Family Services did reach out to the volunteer mediators to see if they were still interested in participating. Also, Lisa has to look into funding for this program.

Future Projects to Consider:

Jim Hudack discussed Centre County's request for proposal through their AHTF for new, affordable housing. Jim is drafting a proposal for early 2022 for a temporary pilot program for the construction of new rental or owner occupied housing, the acquisition and rehabilitation of housing units for resale or rent, or land acquisition for proposed projects to be completed in a two year time period. This program would award 4 projects up to \$25,000 each. Jim will prepare the proposal prior to the November 2021 meeting so that it can be reviewed and discussed. Don Delozier felt that interest may be in rehabilitation rather than new construction due to the cost of materials.

Jim also discussed The Department of Aging's program where small cottages are constructed for housing for the elderly. Clearfield County has participated in this. Jim would like to consider looking into this opportunity to increase the housing stock.

Lisa brought up an idea of utilizing funds to renovate the 2nd floor of a 2 story home occupied by an older adult(s) so that someone like a college student could live there paying little in rent, but would help the older adults with maintenance and/or chores around the house. Jim stated that he has never heard of that, but would be something to keep in mind.
