- Crossroads is moving to their new building located on 5th Avenue by Mansion Park. 12 people have already moved and 12 more will be moving. They will be having an open house in the future.
- The Learning Community shared a story about a woman who has been supported in the system for 25+ years. Early in life she had a rough time...lots of anxiety. She is currently living with a family through Supported Living. She went through breast cancer and is doing very well. She is going to the beach in North Carolina with her support family. This will be her first time seeing the ocean.
- Transportation rates for most Blair County agencies will go down. ACEL's transportation is reducing by \$3.49. Another provider is concerned because their rate increased and caused a person to go over their PFDS cap. Providers had an opportunity for public comment.
- There will be a mandatory meeting for residential providers on 8/15/18 with Nancy Thaler. CEO's and CFO's of residential providers are asked to make this meeting a priority.
