Ordinance 3-2022:

Chief Clerk Hemminger requested approval of an Ordinance authorizing the Blair County Board of Commissioners to enter into a Trust Agreement and Bylaws, and authorizing the participation in the Pennsylvania Counties Workers' Compensation Trust (PComp) pursuant to the Pennsylvania Workers' Compensation Act as amended.

ORDINANCE 3-2022

AN ORDINANCE AUTHORIZING BLAIR COUNTY BOARD OF COMMISSIONERS, BLAIR COUNTY PENNSYLVANIA, TO ENTER INTO A TRUST AGREEMENT AND BYLAWS, AND AUTHORIZING THE PARTICIPATION IN THE PENNSYLVANIA WORKERS' COMPENSATION TRUST PURSUANT TO THE PENNSYLVANIA WORKERS'COMPENSATION ACT, AS AMENDED

PREAMBLE

WHEREAS, the Pennsylvania Workers' Compensation Act, 77 P.S. §1 et. seq., as amended (the "Act"), authorizes employers, including "political subdivisions," as defined in the Act, to pool their liabilities through participation in a fund and trust agreement approved by the Pennsylvania Department of Labor and Industry (the "Department"); and

WHEREAS, Pursuant §§1036.1-1037.9 of the Act and the regulations promulgated pursuant thereto, certain counties and county related entities established the Pennsylvania Counties Workers' Compensation Trust ("PComp") to ensure the payment of workers' compensation benefits to the participating counties' respective employees through the creation of a common fund and trust subject to the terms and conditions of a trust agreement and bylaws (the "Trust Agreement and Bylaws") established and executed by the participating counties; and

WHEREAS, PComp and its Trust Agreement and Bylaws have been approved by the Department; and

WHEREAS, the County of Blair (the "County") desires to become a member of PComp in accordance with the Act and the Trust Agreement and Bylaws.

NOW THEREFORE, BE IT ORDAINED AND ENACTED AS FOLLOWS:

The Board of Commissioners of the County of Blair (the "Board") herby enters into, joins and becomes a member of PComp. The Trust Agreement and Bylaws, which is attached hereto as Exhibit"A," is approved substantially in the form attached hereto, the terms of which are incorporated herein by reference. The Board hereby authorizes and directs its officers to execute the Trust Agreement and Bylaws of PComp. The Board also authorizes its officers to execute any other agreement or document, to provide required information, and to do all acts, necessary for its participation in PComp.

The Trust Agreement and Bylaws approved and adopted herewith shall constitute a binding agreement and shall be sufficient warrant and authority for the officials and agents as appointed by the Board to participate and represent the County's interest in PComp.

As a condition of participation in PComp, the County agrees to comply with all the terms and conditions in the Trust Agreement and Bylaws.

The organizational structure of PComp shall consist of a board of Trustees, all as is set forth in the Trust Agreement and Bylaws.

The County delegates to the Board of Trustees of PComp the powers enumerated in the Trust Agreement and Bylaws.

On behalf of the County, PComp is empowered to enter into any contract necessary to effectuate its purposes.

The Trust Agreement and Bylaws may be modified or amended, as set forth therein.

This Ordinance is being adopted pursuant to the provisions of Act No. 44 of July 2, 1993, P.L. 190 and specifically, Article VIII of the Act (77 P.S. §§1036.1-1036.18) to evidence and effectuate the County's decision to participate in PComp, and shall be effective immediately.
