Call for Public Comment on Prison Board Items: Controller Stickel called for public comment on Prison items. Ernest Fuller, PA Prison Society, stated he had a successful walk through at the Prison.

Approval of Minutes from November 16, 2023 Meeting: A motion was made by Sheriff Ott and seconded by District Attorney Weeks to approve the minutes from the November 16, 2023 Prison Board Meeting. The motion was unanimously carried.

Inmate Population Report: Warden Tate provided an updated Inmate Population Report which will be kept on file with the minutes.

Inmate Services Report: Deputy Warden Shaun Edmundson stated: The Peerstar Re-entry Program had 5 participants. The Salvation Army presentation had 8 participants. Women's In-Prison Drug/Alcohol Pre-Release Program had 12 participants. Men's In-Prison Drug/Alcohol Pre-Release Program had 8 participants. Reformers Unanimous had 15 participants. Women's Parenting had 15 participants. Men's Parenting had 15 participants. The Good Will Re-entry Program had 3 participants. The GED Preparation Program has 5 female and 11 male participants. The Work Release Program has 5 participants. The National Alliance on Mental Illness (NAMI) had 4 female and 21 male participants.

Staffing Update: Deputy Warden James Eckard provided a Staffing Report which will be kept on file with the minutes.

COVID-19 Update: Warden Tate stated there were no COVID-19 issues with staff or inmates.
