County Administrator Schmitt announced a change to the Consent Agenda, letter a, second bullet. She stated that behavioral health services now fall under Behavioral Health of the Alleghenies and not the Home Nursing Agency as listed on the agenda. **There were no comments noted.**

<u>COMMISSIONERS COMMENTS:</u> <u>MDJ Aigner's Building – Mural:</u>

Commissioner Erb introduced Deb Bunnell and Marie Little of the Hollidaysburg Arts Council, and extended a sincere thank you on behalf of the Board of Commissioners and the county to all those who were involved with the repainting of the mural on the side of Magisterial District Judge Aigner's Building.

Ms. Bunnell and Mrs. Little both shared a few words regarding the repainting project and expressed their gratitude toward the county for allowing them to complete this project. Ms. Bunnel stated that the paint used in the repainting project should withstand twenty (20) years before needing to be repainted.

GENERAL PROCEDURE.

- As a general rule under our state statute, home rule procedure requires that an election be held with a question about forming a government study commission.
- The government study commission serves as a representation of the community at large in examining the current local government, considering alternatives, reaching decisions on how the local government might best be run and presenting recommendations to the voters.
- The members serve without pay and the commission is disbanded once its work is complete.
- A sample ballot question would be something like: "Shall a government study commission of (seven, nine or eleven) members be elected to study the existing form of government of the municipality, to consider the advisability of the adoption of a home rule charter, and if advisable, to draft and to recommend a home rule charter?"
- The commission can be authorized by ordinance of the governing body or upon petition of the voters.
- The commission has up to nine months to complete this study. If the commission decides that the current form of government is inadequate, it has nine more months to undertake its second task, which is to write a new charter, which would then be placed on the ballot as a referendum for citizens to accept or reject.
- A home rule municipality drafts and amends its own charter and can exercise any power or perform any function not denied by the state Constitution, the General Assembly or its home rule charter.

Commissioner Erb stated that Commissioner Tomassetti's presentation provided a lot of valuable information that is worthy of consideration.

Miss Swigart stated that Workable is not available via a month-to-month plan. She stated that the agreement is due to renew on 10/25/18, however, there are still pending suggested revisions to the contract.

Motion by Commissioner Beam, seconded by Commissioner Tomassetti and unanimously approved to adopt Resolution 389-2018.

Blair County Prison:

Jayme McMahon requested approval of an agreement between the County of Blair, Blair County Prison and WestLaw in the monthly amount of \$156.45, for a West Complete Library Subscription, for a minimum 36-month term, effective from date of agreement signing to October 31, 2021.

Mr. McMahon stated that when the online agreement was prepared and approved this past June, the hardcopy subscription was not included in the agreement. He stated that the county is under a court order to use WestLaw and is required to have this hardcopy subscription available for use.

Discussion followed.

IT Department and Assessment Office:

Don Weakland requested approval of a quote received from CDW-G, in the total amount of \$18,666.89, for the purchase of a BOMGAR Privileged Access Management System. (\$8,919.06 Assessment Technology Fund/\$9,747.83 IT)

Mr. Weakland stated that the IT Department has been engaged in a project this year to limit vendor access to the secure county network. The purchase of the BOMGAR system will provide for secure and audited access by outside vendors to the secure county network.

Mr. Weakland stated that the total purchase cost is \$18,666.89, and that the cost would be split between the Assessment Technology Fund and IT. Departments that need this access would be charged back a portion of the fee that IT would be paying.

Mr. Weakland stated that CDW-G is a Costar's vendor for BOMGAR, however, the Costar's contract which will expire in November has not been renewed.

Discussion followed regarding approving the request pending final approval by the Solicitor of the Costar's Contract. No action was taken and the request will be further discussed at the October 30 meeting.

Blair County Bridge #45, Snyder Township, over Little Juniata River

Rocky Greenland requested approval of a Submerged Lands License Agreement between the County of Blair and the Pennsylvania Department of Environmental Protection, granting Blair County permission to occupy the submerged lands of the Commonwealth in the bed of the Little Juniata River for the repairs to the bridge piers.

Discussion followed.

Motion by Commissioner Beam, seconded by Commissioner Tomassetti and unanimously approved to adopt Resolution 392-2018.

HVAC and Interior Alterations Project

David Albright requested approval a Change Order to the contract between the County of Blair and Kretina Builders, Inc. (General Contractor) in the amount of \$7,619.78, for the labor associated with the installation of a Service Platform (Blair County will purchase the materials) and in the amount of \$8,699.92, for labor and materials associated with the modifications to the existing Ships Ladder.

Mr. Albright provided a brief outline of the requested Change Orders. He stated that first Kretina will construct a permanent access platform in the former skylight shaft that is immediately adjacent to the Clock Tower. They will provide the labor and the county will provide the materials for this project. Mr. Albright stated that the access platform would allow future access to the area by the county.

Secondly, Mr. Albright stated that Kretina will make framing modifications to the bell support platform, which are necessary to accommodate access ladder and hatch installation, and needed to stabilize the structure.

Discussion followed.

<u>Resolution 393-2018</u>: A resolution approving two (2) General Construction Change Orders received from Kretina Builders, Inc., for the Courthouse Interior Alterations and HVAC Improvement Project as follows:

<u>Change Order No. CO-KBI2</u>, in the amount of \$7,619.78, to furnish all labor to construct a permanent access platform in the former skylight shaft adjacent to the Clock Tower, with materials provided by the county, to facilitate future maintenance access to the area by the county; and <u>Change Order No. CO-KBI3</u>, in the amount of \$8,699.92, to furnish all labor and material to make framing modifications to the bell support platform to accommodate access ladder and hatch installation and to stabilize the structure.

Motion by Commissioner Tomassetti, seconded by Commissioner Beam and unanimously approved to adopt Resolution 393-2018.

OLD BUSINESS:

<u>Resolution 378 – 2018</u>: A resolution approving Benecon's 2019 Medical and Prescription Renewal proposal received from JJAN Financial.

Commissioner Erb stated that the Commissioners have had the opportunity in the last week to discuss individually with Mr. Sefchok the 2019 Medical and Prescription Renewal Proposal and ask any questions regarding his recommended option proposal.

Mr. Sefchok recommended that the board consider accepting Funding Option B, with an annual renewal premium of \$1,554,325.00 for fixed costs and \$4,804,288.00, which represents 90% of the maximum anticipated utilization, to be paid in monthly payments over the calendar year. This option also allows for investment of \$533,810.00 of reserves in a separate interest-bearing account, to be held by Benecon, for use upon demand should the county's fund balance become depleted.
