### TODAY'S MEETING WAS RECONVENED FROM THE MARCH 22, 2018 MEETING THAT WAS HELD AT 10:15 AM IN THE COMMISSIONER'S MEETING ROOM

**Call to Order:** Commissioner Erb

**Call for Public Comment:** Commissioner Erb announced one additional item to the agenda. It was the creation of a temporary position in the Election/Voter Registration Office. Commissioner Erb called for public comment on current and additional agenda items. There was no comment at this time.

**Sheriff's Office:** A motion was made by Sheriff Ott, seconded by Commissioner Beam and unanimously carried for the re-creation of the Chief Deputy Position, Non-Union, Excluded, at the starting bi-weekly salary of \$1,730.16 and an expected annual salary of \$44,984.04, which is what was budgeted for 2018, and was approved.

A motion was made by Sheriff Ott, seconded by Commissioner Beam and unanimously carried for the re-creation of the Lieutenant Position, Non-Union, Excluded, at the starting bi-weekly salary of \$1,491.56 and an expected annual salary of \$38,780.46, which is what was budgeted for 2018, and was approved.

**Election/Voter Registration Office:** A motion was made by Commissioner Beam, seconded by Controller Stickel and unanimously carried for the Full-Time Temporary Voter Registration Clerk Position, Non-Union, Non-Exempt, from April 9, 2018 to June 1, 2018, at the starting rate of \$8.24 per hour for 70 hours every 2-week period for an expected bi-weekly pay of \$576.80 and an expected annual pay of \$2,249.52, and was discussed.

After discussion, an amended motion was made by Commissioner Beam, seconded by Controller Stickel and unanimously carried for the Full-Time Temporary Voter Registration Clerk Position, Non-

Union, Non-Exempt, from April 9, 2018 to June 1, 2018, at the starting rate of \$9.18 per hour for 70 hours every 2-week period for an expected bi-weekly pay of \$642.60 and expected annual pay of \$2,249.10, and was approved.

**Adjournment:** Having no further items to discuss, Commissioner Erb adjourned the meeting.
