Elaine Ebersole Conrad Blair County Genealogy Society – Courthouse Stone Faces.

Commissioner Tomassetti introduced Elaine Ebersole Conrad of the Blair County Genealogy Society.

Mrs. Ebersole Conrad provided a brief power point presentation on the progress being made by the Genealogy Society on identifying the fifty-six (56) unique stone faces that are located on either side of all of the 2^{nd} floor windows and also on the clock tour. She stated that to date searches have not yet revealed a list of names of who the faces are.

Mrs. Ebersole Conrad stated that the society has begun their identification search with trying to match head photographs of judges to the photographs of the stone faces. They feel they may have identified the faces of Judge Jeremiah Black, Judge Samuel Calvin, and Judge Martin Bell. Other faces they feel represent that of the Irish and Italian immigrants, Chief Logan Native American Indian, an African American individual representing emancipation, and Philip Klobetanz, a stone mason.

Mrs. Ebersole Conrad encouraged anyone interested in joining in on the face identification search to please do so as the project is ongoing.

Blair County Road 105/Convention Center Boulevard:

Brian Wiser introduced a Proposal of Service Contract from Keller Engineers, Inc., in an amount not to exceed \$27,389.00, plus reimbursable, in the amount of \$200.00, for design, permitting, contract documents and construction services for the repair of the storm-water conveyance from the convention center complex to Convention Center Boulevard (County Road 105).

Mr. Wiser provided a brief summary of the proposal. Commissioner Beam stated that expenses for this project will be shared with the Blair County Sports Facilities Authority, with the county paying 64%, and the remaining 36% being paid by the Sports Facilities Authority.

County Administrator Schmitt asked the board to consider approving authorization to advertise for bids for construction services as well.

Resolution 121-2018: A resolution approving a Proposal of Service Contract received from Keller Engineers, Inc., in an amount not to exceed \$27,389.00, plus reimbursable, in the amount of \$200.00 for design, permitting, contract documents and construction services for the repair of the storm-water conveyance from the convention center complex to Convention Center Boulevard (County Road 105); and authorization to advertise for bids for construction services.

Commissioner Tomassetti noted his abstention on voting on this matter due to a conflict of interest.

Intermunicipal Relations Committee (IRC):

Katrina Pope requested approval for the submission of a Department of Environmental Protection (DEP) Act 101, Section 903 Recycling Grant on behalf of the County of Blair as part of the County of Blair/IRC Agreement. The total grant amount pending DEP approval will be approximately \$48,000.00

Mrs. Pope stated that this is an annual submission request. The grant provides 50% reimbursement of John Frederick's salary, benefits and travel expenses related to recycling.

Discussion followed.

Blair County Sheriff's Office:

Jim Ott requested approval to renew a software maintenance agreement between the County of Blair, Blair County Sheriff and Automated Card Systems (a division of IdentiSys.Inc.) for the period of 03/01/18 to 02/28/19, in the amount of \$641.00, for the SMA-ID-Work Photo ID Card Machine.

Sheriff Ott stated that this is an annual request and that Solicitor Karn's requested changes have been made to the agreement. He stated that the cost does reflect an increase of \$22.80 from last year.

Resolution 123-2018: A resolution approving to renew a software maintenance agreement between the County of Blair, Blair County Sheriff and Automated Card Systems (a division of IdentiSys.Inc.) for the period of 03/01/18 to 02/28/19, in the amount of \$641.00, for the SMA-ID-Work Photo ID Card Machine.

Motion by Commissioner Beam, seconded by Commissioner Tomassetti and unanimously approved to adopt Resolution 123-2018.

Blair County Court Administration:

Scott Schultz requested approval for the submission of a 2018 Drug Court Initiatives Grant Application to the Pennsylvania Commission on Crime and Delinquency (PCCD), in the amount of \$200,000.00, for the enhancement of the county's Adult Drug Court and DUI Court Programs.

Mr. Schultz stated that this is a new grant opportunity for 2018 with a one year grant period which begins on 07/01/18 and ends on 06/30/18. Funds would be used for drug testing; purchase of a vehicle for Adult Parole and Probation; and the hiring of a part-time individual to perform drug testing seven (7) days per week. In order to supplement the hiring of this individual a \$5 fee will be charged to the participant for each drug test they have completed which will be collected through Costs and Fines.

Mr. Schultz stated that there are no required matching funds for this grant.
