Staff Reports & Special Business:

Elections/Voter Registration:

Sarah Seymour requested approval of a County Application and Agreement for 2022 HAVA Grant Funds and Attachment B (Standard Terms and Conditions – Grant Agreements) between the County of Blair and the Commonwealth of Pennsylvania, Department of State, in the total amount of \$9,717.62, to be used for activities to improve the administration of elections for federal office, including to enhance election technology, make election security improvements and implementation of SUREVote, for the period of March 16, 2022 through September 30, 2023.

Discussion followed.

Human Resources:

Katherine Swigart requested approval of a Side Letter between the County of Blair and the Pennsylvania Social Services Union (PSSU), SEIU Local 668 representing union-eligible employees of Children, Youth and Families and County of Blair, effective date of approval, for one-time, not-to-base wages payments as outlined in said Side Letter.

Miss Swigart stated that the Side Letter of Agreement is effective upon commissioner's approval between PSSU, SEIU, Local 668, representing union-eligible employees of Children, Youth, and Families and County of Blair for one-time, not-to-base-wages payments as noted in the Agreement provided in your meeting packets.

Commissioner Webster stated that she opposes the action of paying bonuses to one of the county offices for several reasons. She stated that she feels it is not fair to arbitrarily pay bonuses to one office over the others outside of normal wage and benefit negotiations. Bonuses open the door to additional, increased spending and ultimately, an increase in taxes. Commissioner Webster also stated that she opposes the use of ARPA funds, since those are intended for infrastructure improvements.

Commissioner Erb stated that it is a one-time payment and reminded Commissioner Webster to keep in mind that a similar type request covering non-union employees' is slated for discussion at the upcoming Salary Board Meeting in October.

Resolution 390-2022: Approving a Side Letter between the County of Blair and the Pennsylvania Social Services Union (PSSU), SEIU Local 668 representing union-eligible employees of Children, Youth and Families and County of Blair, effective date of approval, for one-time, not-to-base wages payments as outlined in said Side Letter.

Motion by Commissioner Erb, seconded by Commissioner Burke, nay by Commissioner Webster. Motion passed two-to-one.

Fort Roberdeau:

Glenn Nelson requested approval of a Forever Media, Inc. Autumn Play Fall Promotion with commercial air schedule on WALY 103.9 of 35:60 second commercials along with live promotional mentions, directory listing and Fort Logo on the landing page of Forever-Altoona.com, promoting October special Fort events, in the total amount of \$600.00, to be paid from the Fort's county advertising funds budget.

Mr. Nelson stated that Solicitor Karn reviewed the agreement.

Children, Youth & Families:

Laura Burke requested approval of an agreement between Christine Tyndall, RYT 500, Simply Power Yoga LLC and the County of Blair, on behalf of Blair County Children, Youth & Families, for a one-1 hour restorative yoga class, in the amount of \$250.00. Said fee is 100% reimbursable by the IV-E Caseworker Visitation Grant.

Commissioner Burke stated that Simply Power Yoga provided an hour long training as a part of Caseworker Visitation Grant Day held at Fort Roberdeau's White Oak Hall on September 21, 2022. The training included restorative yoga poses and guided meditation for workers to use at home to reduce stress and cope with trauma. She stated the fee is 100% reimbursable by the IV-E Caseworker Visitation Grant.

Discussion followed.
