Audit 2021:

Dave Scott presented his review of the 2021 Annual Audit.

Mr. Scott presented the financial report for the County of Blair for the year ending 2021. Mr. Scott stated that as of December 31, 2021, the county had a total fund balance of \$15.7 million with \$14 million unassigned, and a positive net change in fund balance of \$400,000.00.

Mr. Scott stated that the Net Pension Liability for year ending 2021 was \$63 million; down from \$96 million in 2020.

Mr. Scott stated that the County's Schedule of Expenditures of Federal Awards for year ended 2021 reflected total federal awards in the amount of \$12 million dollars.

Mr. Scott stated that there are a total of five (5) audit findings; four (4) from previous years' and one (1) new finding for 2021.

Discussion followed.
